6. That the School will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.

That the Principal and Correspondent/Manager of the School have individually gone through the provisions contained in the affiliation & examination bye-laws and the circulars issued by the Board from time to time.
