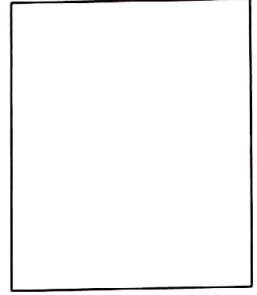

Rules and Regulations for availing transport.

1. The school reserves the right to fix up the boarding points of bus routes.
2. Parents are liable to pay 11 months transport fee for one academic session.
3. Only the enrolled students with valid up to date bus passes are permitted to travel in school bus.
4. Change of boarding point by any student is not allowed without prior permission of school authority.
5. The students are required to deposit their transport fees regularly.
6. The names are enrolled subject to deposit of at least one month transport fees which will be adjusted at the time of discontinuations. One month notice or one month transport fee in lieu of notice period is required to be given for discontinuation.
7. The students are expected to maintain utmost discipline in the bus while travelling.
8. All must reach boarding points before 10 minutes of notified time.
9. All must behave properly with the bus staff and follow instruction given time to time.
10. The senior students should offer seats to their juniors during travel.
11. While boarding/getting down, the students must not run beside the bus, to avoid accidents.
12. In general, the enrolled students are required to pay transport fee for the entire session irrespective of holiday, vacations.
13. No student is allowed to discontinue the bus facility in the mid of the session without any valid reason and without the permission of the school authority.
14. The school reserves the right to reserve the right to increase transport fees on price hike of vehicle consumables.
