- 3. The School shall admit in class I, to the extent of 25% of the strength of that class, children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till this completion. Provided, further that in case of pre primary classes also, this norm shall be followed.
- For the children referred to in paragraph 3, the School shall be reimbursed as per Section 12(2) of the Act. To receive such reimbursements school shall provide a separate back account.
- 5. The Society/School shall nor collect any capitation fee and subject the child of his or her parents or guardian to any screening procedure.
- 6. The School shall not deny admission to any child for lack of age proof. If such admission is sough subsequent to the extended provided prescribed for admission.

On the ground of religion, caste or race, place of birth or any of them.

## 7. The School shall ensure:

- (i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
- (ii) No child shall be subjected to physical punishment or mental harassment.
- (iii) No child is required to pass any board examination till the completion of elementary education.
- (iv) Every child completing elementary shall be awarded a certificate as laid down under Rule-
- (v) Inclusion of Students with disabilities/special needs as per provision of the Act.
- (vi) The teachers are recruited with minimum qualifications as laid under Section 23(1) of the Act.
- (vii) The teacher performs its duties specified under Section 24 (1) of the Act and
- (viii) The teachers shall not engage themselves for private teaching activities.
- 8. The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
