- 4. The High Power Committee shall be competent to review the NOC now granted to the institution concerned and shall be competent to withdraw the same if any violation of terms and conditions laid down in Govt. Acts / Rules / Executive Instructions is noticed in future.
- 5. The Managing Committee shall be constituted in accordance with the Sec-7 of the Odisha Education Act-1969 as amended from time to time.
- 6. The school shall not be shifted from its present location without prior approval of Director, Secondary Education, Odisha.
- 7. At present the school land is not in the name of the School. It will be the responsibility of the management to record the required land (1.50 Ac.) in School name and copy of RoR submitted within one year to the Directorate for continuance of NOC.
